There was a lot of discussion on how the questions and or concerns will be handled and shared. The committee will create a spreadsheet that all submissions will be listed on and this will be a working document. When the minutes from each meeting are posted, the spreadsheet will also be posted. J. Getty is going to check with VT League of Cities and Towns to find out if there are any legal issues with sharing the names of residents who submit questions.

It was also discussed that the Committee meetings will be recorded either via a zoom meeting recording or a voice recorder to assist with creating the minutes accurately. B. Douglas is going to look into setting up a zoom meeting for recording purposes.

Due to the amount of time the public comment agenda item lasted, it was decided that the public comment period going forward will be limited to 15 minutes. There are other ways to submit questions and concerns so this time frame should be ample.

Other than the most obvious Safety, Financials, Enforcement, Town Liability- it was decided that the other topics will be added to this list as the questions and concerns are reviewed.
